APPLICABILITY

Pursuant to the New Mexico Public Regulation Commission's Final Order in Case No. 15-00127-UT, the Company is required to remove all fuel and purchased power costs from base rates and bill such costs through the Fuel and Purchased Power Cost Adjustment Clause (FPPCAC).

Electric service shall be subject to a FPPCAC pursuant to 17.9.550 NMAC (Fuel and Purchased Power Cost Adjustment Clauses for Electric Utilities) and the Final Order in Case No. 18-00006-UT.

The FPPCAC factors, differentiated by service voltage, apply to all kilowatt hours (kWh) consumed by customers taking retail service under the Company's retail rate schedules and will appear on the Customer's monthly bill as a line item calculated based on metered energy.
